#### **Clubhouse Landscaping Upgrades**

• The third and final phase of the clubhouse landscaping upgrades should be completed by May 1, 2020. The project was awarded to Sundown Gardens and they have agreed to complete the project before the clubhouse rental season begins for graduation celebrations.

#### Village Farms Entryway Upgrades

• Brightview provided us with an entryway upgrade plan two to three years ago but complete action was not taken at that time. Brightview is updating their plan at this time for our review and entryway prioritization before the spring planting season begins.

#### Village Farms Drainage Concerns

 No word has been received from the Hamilton County Surveyor's Office regarding our concern with the poor drainage in many areas of Village Farms. We will allow them 90 days from the date of our last letter which included our concerns along with specific addresses in Village Farms before our follow up.

#### **New Resident Reception**

- In an effort to enhance our new resident inclusion and level of engagement, it is
  recommended the board consider launching an annual "New Resident Welcome Reception"
  starting in October 2020. In reviewing the historical records early October is recommended as
  the majority of real estate transactions occur during the May thru August time period. This
  reception would include:
  - An early evening reception attended by the officers and board members for new residents of Village Farms. The first reception could include those who are new to Village Farms since 2018 in order to reach as many new residents as possible. The HOA president would act as the host for the evening. Beverages and appetizers would be served in an informal setting.
  - Recommendation would be September 15<sup>th</sup> from 6pm-7pm prior to the board meeting
  - The officers and board members in attendance would offer a brief overview of their responsibilities and current activities. The presentations should be a no-pressure overview and provide involvement options for those interested in volunteering.
