Planning and Development - Karl Krukenberg

- Road Resurfacing
 - Get rest of neighborhood in the next 1-3 years. Depends on new administration budget available
 - O Due to our size, the whole neighborhood cannot be addressed all at once
 - There is a system that scores/rates conditions of roads
 - Will address inlet protection with city/contractor for future roads
 - o Email the city to inquire about whether your specific road will be repaired
- Oak Ridge Trail Connection
 - Will investigate what their maintenance crew can put together
 - City will take a serious look at it
 - City unsure if east side connection will extend all the way to Greyhound Pass or if they will install a crossing at Citation/McNamara, which is considered a mid-block crossing and less safe than pedestrians crossing at Greyhound
 - o Possible timeline for construction within the year
- Greyhound Pass
 - Looking into culvert condition
 - o Evaluate pavement condition with geotechnical investigation
 - If full reconstruction, then they would push back the timeline to fully use existing pavement life
 - o If mill and overlay can buy more time to extend the overall life of the pavement, then it will happen relatively earlier
- Signage Updates
 - Some yield signs will change to stop signs to comply with newly passed City ordinance

- Rip Rap along Greyhound Pass east of Oak Ridge (resident concern)
 - Rip rap is bring thrown into the lake. I'd like to wait just a little while longer to see if Karl learns any more about the timeline of reconstruction of the tubes (if there is one) so that we do not replace rip-rap and then a major construction project happens there shortly after
- Algae growth in lower lake (resident concern)
 - Lakes are treated on a regular schedule and with the cooler temperatures and recent rains finally introducing more fresh water to bring the water temps down the chemical treatments should have an easier time catching up and getting ahead of the algae growth.
